



## LICENCE AGREEMENT

THIS AGREEMENT is made the                      day of                      2012

BETWEEN

THE ROTARY CLUB OF BRIGHT INC. of Bright (hereinafter called "the Licensor") of the one part

AND

\*\*

(hereinafter called the "Licensee") of the other part.

WHEREAS:-

A. The Licensor is the owner of a 5.8m enclosed mobile workshop ("the Mobile Workshop") located in Dili, East Timor, and has agreed to grant a licence to the Licensee ("the Hirer") to hire the Mobile Workshop on the following terms and conditions.

NOW IT IS AGREED AS FOLLOWS:-

1. In consideration of the weekly sum of \$550 to be paid by the Licensee to the Licensor the Licensor hereby licences and authorises the Licensee and all persons authorised by it to use the Mobile Workshop from the                      day of 2012 to the day of                      2012 .

The total sum payable including a security bond of \$1000 must be paid in full into an account designated by the Licensor 30 days prior to the Mobile Workshop being used by the licensee.

2. The Licensee shall be given an inventory and condition report on the Mobile Workshop and its equipment and consumables when it takes possession of the Workshop and hereby agrees to assume responsibility for the security and safeguarding of the Mobile Workshop while it remains in its possession.

3. The Licensee acknowledges that the Mobile Workshop is equipped with electric brakes and that the designated driver is familiar with their use.

The Licensee will also hire the Toyota 4 x 4 vehicle arranged through the Rotary Liaison Officer to ensure the proper function of the electric brakes.

4. In the event that any damage is caused to the Mobile Workshop, or any of its equipment is lost by the Licensee or any person authorised by it, the Licensee shall be responsible for such repair or replacement and agrees to make good any such damage at its own expense.

Any consumables used by the Licensee must be replenished by the Licensee in East Timor at the end of the hire period.

5. The Licensee acknowledges that the security bond may be used to make good any loss or repairs to the trailer or equipment if required but this does not remove the obligation of the licensee to make good repairs in excess of this amount.

6. The licensee will complete an inventory and condition report on the Mobile Workshop and its equipment and consumables at the end of the respective hire period and return it together with the trailer to the designated location, make it secure and return the keys to the Rotary Liaison Officer or other appointed persons.

The security bond will be returned in full or part within 30 days of the end of the hire period.

7. In the event of a cancellation all money will be refunded in full.
8. Any dispute which may arise will be determined under the jurisdiction of the State of Victoria.
